

ADULT VOLUNTEER AGREEMENT FORM

Every parent and leader attending community camping must read and sign this form.
**THE SIGNED FORM OF EVERY PARENT/LEADER ATTENDING COMMUNITY CAMPING MUST BE TURNED IN WITH
REGISTRATION FORMS.**

I, _____, understand as a leader/co-leader/chaperone of Troop _____, I play an important role in the success of this camping trip. My attitudes, behaviors, and responsibilities as a role model are critical to the success of the camping trip.

For these reasons, I agree to the following:

- The use of alcohol or drugs will not be tolerated; and the usage at any time during the event, will result in immediate expulsion from the event.
- I will refrain from smoking and vaping the entire community camping trip while on the Grounds of Sharpe Reservation.
- I understand Sharpe Reservation is a smoke-free camp in accordance with New York State Law.
- Use of alcohol, drugs, and smoking by the girls are prohibited at any time during the event, will not be tolerated and will result in expulsion from the event.
- NO siblings are allowed at the camp-out at any time. No child under the age of 5 is allowed. Only registered Girl Scouts between the age of 5-18 are allowed. No boys are allowed. I understand if I come to the campout with a sibling, I will be asked to leave.
- As the leader/co-leader/chaperone, I understand this event is a troop event NOT a parent/daughter event. I will only have as many adults as are needed to drive (1 adult for every 4 scouts). If extra adults come, I understand that I will have to tell them to leave.
- I must provide adult supervision of the girls at all times unless otherwise indicated by the trip leader. I understand that the girls cannot attend workshops without an adult. No minors are allowed in any buildings unsupervised.
- There is absolutely no use of activity areas and/or equipment including boats, rope courses, and fire pits during non-activity hours.
- At no time can any cabins be re-arranged from its original state.
- There are no food deliveries of any kind at any time during community camping. There is absolutely no food allowed in the cabins at any time- If this happens, I know I will be asked to leave the trip with my entire troop.
- Quiet time and lights out will be strictly enforced at 10pm.
- Remember that not only is it important that my daughter have an enjoyable time, other girls in the troop need my attention and guidance as well.
- Work with the camp leader and the volunteers assisting before and during the trip.
- Be sensitive to the needs of each girl participant.
- Respect the places and people we visit and the people with whom we share the campsite.
- Be responsible for my own equipment and be sure the girls are responsible for theirs
- I will follow the GSUA, GSHH and Sharpe Reservation safety rules and regulations at all times.
- I understand that not following these rules will result in expulsion from this event and all other community events for the year.
- Promptly provide all information and forms required.
- I will ensure all required forms are completed by the girls and their families and returned by the due dates.
